BUY AMERICAN ACT (BAA)

- **Used in**: Direct federal procurement (e.g. DoD, GSA).
- Requirement: Products must be U.S.-made with 65% U.S. content by cost (moving to 75% by 2029).
- **SBM Compliance Position:** Shades by Matiss manufactures within the United States, with a minimum of 55% domestic content already exceeding Build America, Buy America (BABA) thresholds.
- For BAA-specific projects, SBM offers documentation of domestic production and sourcing to demonstrate compliance.
